Payment Policy

Market Attendance

Vendors are expected to arrive for set up 30 minutes prior to the market opening. If vendors arrive after 8:30 without giving notice to the market manager their table will be reallocated or removed without reimbursement.

Please use the dedicated entrances and exits for loading. Please do not move tables and chairs unless given permission from the market manager as spacing has been preset to accommodate vendors as comfortably and uniformly as possible.

PAYMENT

Vendors who wish to purchase Seasonal and 10 Week Spaces are required to pay, in full, on or prior to June 1, 2020. Payment can be made by: Cheque, Cash or Credit Card; cheques are made payable to the City of Kenora.

Seasonal vendors looking to purchase 4 or more spaces will be given a bulk discount:
4 Spaces – 10% discount on the total price

Casual Vendors must pay, in full, on the Market day they wish to participate in. Payment can be made by: Cheque or Cash. Cheques are made payable to the City of Kenora.

CANCELLATION AND REFUND

A service charge of \$5.00 will be applied to all Refund requests

* Partial refunds will not be granted – some exceptions may apply, please speak to Market Manager on a case by case basis.

No refund, or rebooking, will be available to Vendors who do not show up on Market day and provide no advanced notice.

If 2 days' notice is provided, the Market Manager will attempt to rebook at a later date. Please note – spaces will not be guaranteed during the peak season of July and August.

Casual vendors who do not show will be required to pay, in full, for a future reservation at the time of booking.
